4. <u>Nationals Financing</u> Unit planned revenue events:

Regional Tournament 29Jun-05Jul2020

Discussion – Important sources of money are sectional and regional tournaments. For the Regional Tournament, even if the event is held, attendance is expected to be decreased due to COVID-19 and revenue will likely be lower than expected. Additionally, the risk to the bridge community's elderly population is significant. A final decision is needed by 01May2020. More follow-up/discussion is necessary to determine what will happen with the Regional Tournament given the self-isolation that has been implemented throughout Austin. ACBL has not provided any recommendations for schedule change or cancellation of events due to COVID-19. The individual event naming is postponed until it is determined if/when a regional tournament could occur. Pat White was suggested as a potential "event named" honoree
