Christmas Parties

There are several Christmas parties in the offing.

- (1) The **South Austin** Senior Activity Center party is Dec 8th (Tues at 12:30). It is a unit-rated event.

North American Pairs

The district-final (for those having qualified at the unit-level) Jan 9th and 10th (Sat/Sun) at the DoubleTree Hotel in conjunction with the Austin Sectional. It will be a four-session event. About half of the field is eliminated after the first two sessions. A meal will be served between sessions on Sunday. District-level winners (3 or 4 each strat) advance to the Spring Nationals.

Grand National Teams (GNT)

The unit-level GNT qualifier for flights B and C will be held on Feb 20th (Sat) at the BCA. It is a two-session event. The upper half of each flight qualifies to go the district-level (usually held in Richardson (Dallas) over the Memorial Day weekend). The national-level is at the Summer Nationals. Must play both sessions.

Mentor Program

Unit 207 will again sponsor a Mentor program, beginning on January 15th, 2010. Current plans call for "mentees" (those being mentored) to have less than 25 masterpoints when applying for the program. One may not be a mentee if previously enrolled in this program. Sign-up deadline is Dec 15th. The five-month program will run from January to May. Mentors may play bridge (free!) with their mentees (who *do* pay, but only for themselves) twice per month. Any bridge club is suitable. One need not always play at the same club. Mentors/mentees may play bridge more than twice per month, but the Unit will subsidize (the mentors) only two games per month.

Declarer's Cards - Played vs Penalty

There seems to be constant confusion about this. Declarer never has a penalty card. If declarer *illegally* plays a card (such as an un-established revoke or an unaccepted lead out of turn), said card is returned to the declarer's hand - it does not become a penalty card (as it would if the card had been played by a defender). However, if declarer *plays* (touching or nearly touching the table or held in such a manner as to indicate that the card is played) *a legal card*, that card may not be returned to declarer's hand - it is played. The fact that declarer wishes that he had not *played* the (legal) card from his hand or from the dummy is *not* grounds for returning the card to his hand and playing another card.

Bad Claims

When a claim is made, *play ceases*! If you believe that the claim is invalid, call the director. It is unwise for the defense to request that the declarer play it out. That request alerts the declarer that something is perhaps amiss with his claim and gives him an unwarranted chance to rectify it. The defense is much better served by having the director come to the table to sort things out. Remember that doubtful points are awarded to the "non-offending" (those not making the claim) side. If you are (even remotely, but not due to *irrational* declarer play) due a trick(s) because of a bad claim, the director's job is to insure that you get the trick(s). Once a claim is made, the defense gets to cooperate completely in the defense as if they were seeing their partner's hand (by giving partner an unexpected ruff, for example).
