## **Transfer or Relay?**

When giving an explanation of your bidding to the opponents, make sure to use the proper terminology with respect to "transfers" and "relays". A transfer bid promises the suit in question. For example, if 2NT is a transfer to diamonds, then the 2NT bidder promises holding a diamond suit. However, if the 2NT bid were a relay to 3 Diamonds (the responders is "required" to bid 3D), the 2NT bidder does not promise a diamond suit (although he might happen to have one). If you tell the opponents that a certain bid is a transfer (say to 3 Clubs) when that bid is actually a relay, the opponents are going to (erroneously) assume that the bidder has (for sure) a certain suit (Clubs). This misuse of terminology might adversely affect the opponents' bidding, in which case they might be damaged and entitled to redress from the director.

## **"Not Played" Result**

Occasionally, the director will "award" a result of "Not Played" (often because the round has been called, a table is a full board behind and there is not time enough (perhaps due to traffic considerations) after the game to do a "Late Play"). There is **no penalty** for a "Not Played" - it is "scored" exactly like a sit-out. You do not get a zero! The score of those affected by the "Not Played" is factored up (i.e. multiplied) by the ratio: (# of boards potentially played) divided by (# of boards actually played) just as it would be had there been a sit-out. For example, if 24 boards is the norm, but, due to a "Not Played", only 23 boards are actually played by a pair, that pair has their score multiplied by 24/23. (Had the pair actually sat-out for 3 boards, their score would have been multiplied by 24/21. Since they sat out for 3 boards, they played 21 of the 24 boards.)
