### **I-35 Cup (Austin vs. San Antonio)**

The team game (Swiss) competition begins March 3<sup>rd</sup> at the BCA at **10:00** with four flights: unlimited, 751 - 2500, 300 - 750 and 0-299. The event will be **flighted** (segregated). Flight A teams will only play other Flight A teams, Flight B teams will only play other Flight B teams, etc. The winning team *from each flight* will qualify to play in the two-session final held in Austin on May 12<sup>th</sup>. The winning team *of each flight* from San Antonio will compete against the winning team *of the same flight* from Austin in two 24-board matches, ACBL 30-VP scale.

### **Correct Information But *Incorrect Dummy/Declarer/Defender***

Sometimes the dummy (or declarer's hand or defender's hand) is (quite) different from what an opponent said that it would be. If this happens, you are not necessarily *legally* damaged, even though you might be *actually* damaged. (There is **no** penalty if you are not *legally* damaged, even if you've been *actually* damaged.) Why is this?? Recall that the person describing his partner's bid is required to divulge what partner is *supposed* to have (which *is* usually what his partner *actually* has). As long as this information about partner's *supposed* (by their bidding agreements) hand is correct, you are not *legally* damaged even if his partner's hand is actually (quite) different from the description. The opponent might have mis-bid or might have distorted or lied about his hand (neither of which is against the rules). Remember, an opponent is not required to describe what is *actually* in his partner's hand. He can't see his partner's hand, so he doesn't really know what's in it. He describes what he *supposes* to be in his partner's hand (based on their bidding agreements).
